The purpose of this circular is to, among others: (i) provide you with details of the proposed Issue Mandate and the proposed Repurchase Mandate; (ii) set out an explanatory statement regarding the Repurchase Mandate; (iii) provide particulars of the Directors to be re-elected or appointed; and (iv) give you notice of the AGM.

---

The purpose of the general mandates was to enable the Directors to issue additional Shares should the need arise. Ordinary resolutions will be proposed at the AGM for approval of, amongst others, the granting to the Directors of the following new general mandates:

- (i) to allot, issue and otherwise deal with Shares (including any sale or transfer of Treasury Shares out of treasury) with an aggregate number of Shares not exceeding 20% of the aggregate number of Shares in issue (excluding Treasury Shares, if any) as at the date of passing the proposed resolution at the AGM;
- (ii) to repurchase Shares with an aggregate number of Shares not exceeding 10% of the aggregate number of Shares in issue (excluding Treasury Shares, if any) as at the date of passing the proposed resolution at the AGM; and
- (iii) to extend the Issue Mandate by the amount equal to the number of Shares repurchased by the Company pursuant to the Repurchase Mandate (“**ተገደደበት**”) (if granted to the Directors at the AGM).

As at the Latest Practicable Date, the Listing Rules provide that, unless the Stock Exchange agrees otherwise, in the event the Issue Mandate is exercised and Shares are placed for cash consideration under the Issue Mandate, the issue price of the Shares may not be at a price which represents a discount of 20% or more to the benchmarked price of the Shares, such benchmarked price being the higher of:

- (i) the closing price of the Shares as quoted on the Stock Exchange on the date of the relevant placing agreement or other agreement involving the proposed issue of securities under the Issue Mandate; and
- (ii) the average closing price of the Shares as quoted on the Stock Exchange in the 5 trading days immediately prior to the earlier of:
  - (a) the date of announcement of the placing or the proposed transaction or arrangement involving the proposed issue of Shares under the Issue Mandate;
  - (b) the date of the placing agreement or other agreement involving the proposed issue of Shares under the Issue Mandate; and
  - (c) the date on which the placing or subscription price is fixed.

An explanatory statement containing information relating to the Repurchase Mandate is set out in Appendix I to this circular.

In accordance with clause 99 of the Bye-laws, Mr. Wong Man Li, Ms. Hui Wai Hing and Mr. Chau Shing Yim, David will retire by rotation at the AGM.

Mr. Wong Man Li and Ms. Hui Wai Hing, both being eligible, will offer themselves for

The Board proposed to appoint Mr. Chan Hak Kan (“陳國權”) as an independent non-executive Director. The proposed appointment of Mr. Chan is subject to the approval by the Shareholders at the AGM by way of an ordinary resolution and will take effect, if approved, from the conclusion of the AGM. The biographical information of Mr. Chan and further information required to be disclosed pursuant to Rule 13.51(2) of the Listing Rules is set forth below:

Mr. Chan, aged 50, graduated from The Chinese University of Hong Kong, obtained a bachelor’s degree in social science in 1997, and further obtained a master’s degree in social science in 2003. Mr. Chan has been the chairman of Democratic Alliance for the Betterment and Progress of Hong Kong since September 2023. From January 2000 to December 2003, Mr. Chan served as an elected member of the Sha Tin District Council. From October 2008 to October 2011, July 2012 to June 2018, October 2016 to December 2021, January 2017 to December 2022, January 2019 to December 2024 and March 2022 to December 2025, Mr. Chan served as a member of the Council of The Chinese University of Hong Kong, Beat Drugs Fund Association Governing Committee, Tung Wah Group of Hospitals Advisory Board, ICAC Advisory Committee on Corruption, Witness Protection Review Board and Po Leung Kuk Advisory Board, respectively. Mr. Chan has been a member of the HKSAR Legislative Council and the HKSAR Executive Council since October 2008 and July 2022, respectively. Prior to becoming a member of the Legislative Council, Mr. Chan was appointed as special assistant to the Chief Executive of Hong Kong. Mr. Chan has been a non-executive director of The Hong Kong Mortgage Corporation Limited since June 2022. Mr. Chan was appointed as the Justice of the Peace by the Chief Executive of Hong Kong in 2012, was awarded a Bronze Bauhinia Star in 2016, and was awarded a Silver Bauhinia Star in 2021.

Mr. Chan is currently an independent non-executive director of Xinyi Electric Storage Holdings Limited (stock code: 8328), which is listed on the GEM of the Stock Exchange, and an independent non-executive director of Oshidori International Holdings Limited (stock code: 622), Imagi International Holdings Limited (stock code: 585), China Resources Power Holdings Company Limited (stock code: 836) and Accel Group Holdings Limited (stock code: 1283), all of which are listed on the Main Board of the Stock Exchange.

Subject to the approval by the Shareholders at the AGM on the appointment of Mr. Chan as an independent non-executive Director, a service contract will be entered into between the Company and Mr. Chan for a term commencing from the date of approval of the Shareholders at the AGM and expiring on the third anniversary of the date of the service contract, and his appointment is subject to the applicable rules and provisions and the Bye-laws of the Company regarding retirement and re-election at the annual general meetings of the Company. The service contract of Mr. Chan may be terminated by either party giving at least three months’ prior notice in writing. Pursuant to such service contract, Mr. Chan will be entitled to director’s fees of HK\$430,000 per annum. The director’s fee of Mr. Chan is recommended by the Remuneration Committee and determined by the Board with reference to his duties and responsibilities as an

independent non-executive Director as well as the remuneration policy of the Company and subject to review from time to time.

As at the Latest Practicable Date, save as disclosed above, Mr. Chan has confirmed that (i) he does not have any relationship with any Directors, senior management, substantial shareholders or controlling shareholders of the Company; (ii) he does not have any interest in the shares of the Company within the meaning of Part XV of the SFO; (iii) he does not hold any position in the Group; and (iv) he has not held any other directorships in the last three years in any other public companies the securities of which are listed on any securities market in Hong Kong or overseas.

Mr. Chan has confirmed that (i) he has satisfied all the criteria for independence set out in Rule 3.13(1) to (8) of the Listing Rules; (ii) he had no past or present financial or other interest in the business of the Group or any connection with any core connected persons of the Company; and (iii) there are no other factors that may affect his independence at the time of his appointment. He has confirmed that he is not aware of any other matter in relation to his appointment that needs to be brought to the attention of the shareholders of the Company, and, save as disclosed above, there is no other information which is required to be disclosed pursuant to the requirements of Rules 13.51(2) of the Listing Rules.

The Nomination Committee has assessed the independence of Mr. Chan. After taking into account all the factors for assessing the independence as set out in Rule 3.13 of the Listing Rules and considering his confirmation of independence to the Company, the Board is of the opinion that Mr. Chan has satisfied the criteria as set out in Rule 3.13 of the Listing Rules.

Having considered the background and experience of Mr. Chan, and the recommendations of the Nomination Committee, the Board believes that Mr. Chan would further enhance the effectiveness of the Board in supervision and management of risk areas. The Board proposes to elect Mr. Chan as an independent non-executive Director and an ordinary resolution will be proposed at the AGM for the Shareholders to consider and approve the appointment of Mr. Chan as an independent non-executive Director with effect from the conclusion of the AGM.

Ernst & Young will retire as the independent auditor of the Company at the AGM and, being eligible, offer themselves for re-appointment. Upon the recommendation of the Audit Committee, the Board proposed to pass an ordinary resolution to approve the re-appointment of Ernst & Young as the auditors of the Company and to hold office until the conclusion of the next annual general meeting of the Company and to authorize the Board to fix the auditor's remuneration.

The estimated audit fee for the audit of the consolidated financial statements of the Group for the financial year ending 31 March 2027 is expected to be in the range of approximately HK\$1.6 million to HK\$2.0 million (exclusive of out-of-pocket expenses).

The estimated audit fee represents a fair and reasonable estimation, after due consideration and arm's length negotiation between the Company and Ernst & Young. The estimation takes into account various factors such as the size and structure of the Group, the nature and complexity of the Group's businesses, the expected scope, timetable and direction of the audit and the time and resources etc. deployed by the auditor.

Furthermore, the estimated audit fee assumes there will be no material changes in the Group's businesses and operations, accounting policies or regulatory environment, and that the Company will provide timely and adequate assistance and information as required for the audit. Unless there is a material change in the basis or assumptions set out above, the final audit fee should not deviate materially from the estimated amount initially disclosed. In the event of any material change, the Company will make further disclosure as appropriate.

Pursuant to the Listing Rules, voting by poll is mandatory at all general meetings except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. The chairman of the AGM will request for voting by poll on all of the proposed resolutions set out in the notice of the AGM. As at the Latest Practicable Date, to the extent that the Company is aware having made all reasonable enquires, no Shareholder has to abstain from voting on any of the proposed resolutions at the AGM. The results of the poll will be published on the websites of the Company and the Stock Exchange on the day of the AGM.

Shareholders whose names appear on the Company's register of members on Friday, 3 July 2026 will be eligible to attend and vote at the AGM. The transfer books and register of members will be closed from Monday, 29 June 2026 to Friday, 3 July 2026, both days inclusive, during which period no transfer of Shares will be effected. The record date for determining shareholders' entitlement to attend and vote at the AGM will be Friday, 3 July 2026. In order to determine the identity of Shareholders who are entitled to attend and vote at the AGM, all

transfers accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch registrar, Computershare Hong Kong Investor Services Limited, at Shops 1712–1716, 17/F, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 4:30 p.m. on Friday, 26 June 2026.

As stated in the announcement of the Company dated 15 May 2026 relating to the final results of the Group for the year ended 31 March 2026, the Board has proposed a final dividend of HK9 cents per Share for the year ended 31 March 2026. Shareholders whose names appear on the Company's register of members on Monday, 13 July 2026 will qualify for the proposed final dividend. The Company's transfer books and register of members will be closed from Thursday, 9 July 2026 to Monday, 13 July 2026 (both days inclusive) for the purpose of ascertaining shareholders' entitlement to the proposed final dividend. The record date for determining shareholders' entitlement to the proposed final dividend will be Monday, 13 July 2026. In order to qualify for the proposed final dividend, all transfer forms accompanied by the relevant Share certificates must be lodged with the Company's branch share registrar and transfer office in Computershare Hong Kong Investor Services Limited located at Shops 1712–1716, 17/F, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 4:30 p.m. on Wednesday, 8 July 2026. The proposed final dividend (the payment of which is subject to the Shareholders' approval at the AGM) is expected to be paid on Wednesday, 22 July 2026 to Shareholders whose names appear on the register of members of the Company on Monday, 13 July 2026.

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief, the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement in this circular or this circular as a whole misleading.

The Directors consider that all the proposed resolutions are in the interests of the Company and the Shareholders. Accordingly, the Directors recommend that the Shareholders vote in favour of all resolutions as set out in the AGM Notice.

Your attention is also drawn to the additional information set out in the Appendices to this circular.

*This appendix includes an explanatory statement required by the Stock Exchange to be presented to Shareholders concerning the Repurchase Mandate proposed to be granted to the Directors.*

**1. *General Mandate for the Repurchase of Shares***

The Listing Rules permit companies with a primary listing on the Stock Exchange to repurchase their shares on the Stock Exchange subject to certain restrictions.

**2. *General Policy for the Repurchase of Shares***

Any repurchase will be made out of funds which are legally available for the purpose in accordance with the Memorandum of Association and Bye-laws, the laws of Bermuda and the Listing Rules. Such repurchases may only be effected out of profits of the Company or out of a fresh issue of shares made for the purpose, or, if so authorised by the Bye-laws and subject to the provisions of the Companies Act, out of capital. Any premium payable on a repurchase over the par value of the shares to be repurchased must be provided for out of profits of the Company or out of the Company's share premium account, or, if so authorised by the Bye-laws and subject to the provisions of the Companies Act, out of capital.

As compared with the financial position of the Company as at 31 March 2026 (being the date to which the latest audited financial statements of the Company have been made up), the Directors consider that there would not be a material adverse impact on the working capital or the gearing position of the Company in the event the proposed repurchases were to be carried out in full during the proposed repurchase period.

The Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital or the gearing position of the Company which in the opinion of the Directors are from time to time appropriate for the Company.

**3. *Number of Shares to be Repurchased***

As at the Latest Practicable Date, the total number of issued shares of the Company was 3,878,083,200 Shares.

Subject to the passing of the relevant ordinary resolutions to approve the general mandates to issue and repurchase Shares and on the basis that no further Shares are issued or repurchased prior to the date of the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 387,808,320 Shares.

If the Company repurchases Shares pursuant to the Repurchase Mandate, the Company may (i) cancel the repurchased Shares and/or (ii) hold such Shares in treasury, subject to market conditions and the capital management needs of the Company at the relevant time such repurchases of Shares are made. If the Company holds Shares in treasury, any resale of Shares

---

held in treasury will be made in accordance with the Listing Rules and applicable laws and regulations of Bermuda.

To the extent that any Treasury Shares are deposited with CCASS pending resale, the Company will adopt appropriate measures to ensure that it does not exercise any shareholders' rights or receive any entitlements which would otherwise be suspended under the applicable laws if those Shares were registered in the Company's own name as Treasury Shares. These measures may include approval by the Board that (i) the Company will not (or will procure its broker not to) give any instructions to Hong Kong Securities Clearing Company Limited to vote at general meetings for the Treasury Shares deposited with CCASS and (ii) in the case of dividends or distributions, the Company will withdraw the Treasury Shares from CCASS, and either re-register them in its own name as Treasury Shares or cancel them, in each case before the record date for the dividends or distributions.

4. **General authority to repurchase Shares**

The Directors believe that it is in the best interests of the Company and the Shareholders to have a general authority from the Shareholders to enable the Directors to repurchase Shares on the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole.

5. **Exercise of the authority to repurchase Shares**

The Directors will exercise the power of the Company to repurchase Shares pursuant to the Repurchase Mandate in accordance with the Listing Rules, the applicable laws of Bermuda and the Memorandum of Association and Bye-laws of the Company. Neither the explanatory statement in this Appendix I nor the proposed share repurchase has any unusual features.

6. **Consequences of repurchase of Shares**

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. As a result, a shareholder or a group of shareholders acting in concert, depending on the level of increase of the shareholder's interest, could obtain or consolidate control of the Company and may become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Directors, Mr. Wong Man Li, the chairman and an executive Director of the Company, was interested in 2,429,156,400 Shares, representing approximately 62.64% of the issued share capital of the Company, 2,426,692,800 Shares of which were held through Man Wah Investments, a controlling shareholder of the Company, representing approximately 62.57% of the issued share capital of the Company.

In the event the Directors exercise in full the power to repurchase Shares pursuant to the Repurchase Mandate and on the assumption that Mr. Wong Man Li, whether by himself or through Man Wah Investments, does not dispose of or purchase any Shares or exercise any right to subscribe for any Shares, the shareholding interest of Mr. Wong would increase to approximately 69.6% of the issued share capital of the Company and such increase is not expected to give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors have no present intention to repurchase Shares to such an extent as would result in less than 25% of the Shares being held by the public.

The particulars of the Directors who are subject to re-election at the AGM are set out below:

(1) Mr. Wong Man Li (王 萬 里)

Mr. Wong Man Li (王 萬 里), aged 61, Member of the National Committee of Chinese People's Political Consultation Conference (全國人民代表大會), BBS, JP, is our executive Director, Chairman, Chief Executive Officer (the "CEO") and Managing Director, and is also the Chairman of the Nomination Committee and a member of the Remuneration Committee. He is responsible for the day-to-day overall management of our Company and mapping our growth strategy. In May 2015, Mr. Wong was elected as an Executive Chairman of the Hong Kong Industrial & Commercial Association (香港工商總會) and as a Founding Chairman of the Happy Hong Kong Foundation Company Limited (築福香港基金會有限公司). Mr. Wong is the husband of Ms. Hui Wai Hing, an executive Director, and the father of Ms. Wong Ying Ying, also an executive Director. Mr. Wong is a director of Man Wah Investments Limited, the controlling shareholder of the Company.

As at the Latest Practicable Date, 2,426,692,800 Shares were beneficially owned by Man Wah Investments which, in turn, is owned as to 80% by Mr. Wong and 20% by Ms. Hui Wai Hing respectively. Mr. Wong is therefore deemed to be interested in 2,426,692,800 shares of the Company. Mr. Wong also holds 35,600 share options. Upon exercise of the share options, Mr. Wong will directly own an aggregate of 35,600 Shares. Mr. Wong is also deemed to be interested in the 2,428,000 Shares in which Ms. Hui Wai Hing, the spouse of Mr. Wong, had a long position within the meaning of Part XV of the SFO.

Mr. Wong has an existing service contract with the Company for his appointment as an executive Director which was renewed for a term commencing from 1 July 2023 and expiring on the earlier of the date of the Company's annual general meeting in 2026 and the third anniversary of the date of the commencement of the renewed term. Pursuant to such service contract, Mr. Wong is entitled to an annual remuneration of HK\$380,000 for his service as an executive Director in addition to discretionary bonus and other benefits and allowances to be determined by the Board. Mr. Wong is also entitled to other remunerations for his other positions held within the Group. Mr. Wong's emoluments are determined by the Board by reference to the prevailing market rate and his time, effort and expertise devoted to the Company's affairs. Such service contract can be terminated by either party giving at least three months' prior notice in writing.

Save as disclosed above, Mr. Wong has confirmed that (i) he does not have any relationship with any other directors, senior management, substantial shareholders, or controlling shareholders of the Company; (ii) he does not have any interest in the shares of

the Company within the meaning of Part XV of the SFO; (iii) he does not hold other positions with the Company or other members of the Group; and (iv) he has not held any other directorships in the last three years in any other public companies the securities of which are listed on any securities market in Hong Kong or overseas.

1. A form of proxy for the annual general meeting is enclosed.
2. Any shareholder of the Company entitled to attend and vote at a meeting of the Company or a meeting of the holders of any class of shares in the Company shall be entitled to appoint another person as his proxy to attend and vote instead of him. Votes may be given either personally or by duly authorised corporate representative or by proxy. A shareholder who is the holder of two or more shares may appoint more than one proxy to attend on the same occasion. A proxy need not be a shareholder. In addition, a proxy or proxies representing either an individual shareholder or a shareholder which is a corporation, shall be entitled to exercise the same powers on behalf of the shareholder which he or they represent as such shareholder could exercise, including the right to vote individually on a show of hands.
3. The instrument appointing a proxy shall be in writing under the hand of the appointor or of his attorney duly authorised in writing, or if the appointor is a corporation, either under seal or under the hand of an officer or attorney duly authorised.
4. The instrument appointing a proxy and the power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority shall be deposited at the Company's Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited at 17M, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than forty-eight hours before the time for holding the meeting or adjourned meeting or poll (as the case may be) at which the person named in such instrument proposes to vote, and in default the instrument of proxy shall not be treated as valid.
5. Delivery of an instrument appointing a proxy shall not preclude a shareholder from attending and voting in person at the meeting or upon the poll concerned and, in such event, the instrument appointing a proxy shall be deemed to be revoked.
